# **EGH and SCB Weigh Market Indices Down**

The market indices closed today's trading session on a lower level (d/d), dampened by price declines in Ecobank Ghana and Standard Chartered Bank. The Ghana Stock Exchange's Composite Index (GSE-CI) decreased by 36.10 points to ~2,299 points while the Databank Stock Index (DSI) retreated by 425.05 points to ~29,586 points. The year-to-date returns of the GSE-CI and the DSI are recorded at 36.13% and 32.48% respectively.

A total volume of 85,742 shares valued at  $^{\sim}$ GH¢126,619 exchanged hands on the bourse. Trades in Ecobank Transnational Inc. and PZ Cussons Ghana accounted for  $^{\sim}$ 64% of the total trade volumes.

The equities market recorded a negative market breath; 2 gainers and 3 laggards. Access Bank maintained its lead on the gainers chart for the second consecutive time. The counter advanced by 10Gp to GH¢4.00 while GCB Bank inched up by 1Gp to GH¢4.01.

Ecobank Ghana on the other hand lost 81Gp to GH¢7.24. Enterprise Group similarly trimmed 4Gp off its price to settle at GH¢4.04 while Standard Chartered Bank shed 1Gp to GH¢19.70.
