

#### Terms and Conditions

#### 1 Introduction

- 1.1 These terms and conditions apply to the 'Bosco's Awakening' Direct Debit Giveaway.
- 1.2 By participating in this offer, you acknowledge that you have fully read, understood and accepted to be bound by these terms and conditions.

# (2) Eligibility

To be eligible to participate:

- 2.1 You must be 18 years or older at the time of entry.
